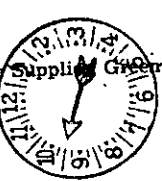

Know All Men by These Presents:

That I, EDWIN F. TUCKER in the State aforesaid, DOLLARS, in consideration of the sum of Ten Dollars and other valuable considerations to the grantor(s) in hand paid at and before the sealing of these presents by the grantee(s) (the receipts whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said Charles W. McCombs, his heirs and assigns, forever:

ALL that certain piece, parcel or lot of land situate, lying and being on the Southwest corner of the intersection of Forrest Park Drive and Helen Street, in Forrest Park Subdivision, formerly known as Gresham Park near the town of Simpsonville in Austin Township, County of Greenville, State of South Carolina, and being shown and designated as Lot No. 65 on Plat of subdivision of Forrest Park; prepared by C. O. Riddle, dated October, 1952, and recorded in R. M. C. Office for Greenville County, S. C. in Plat Book EE, at pages 64 & 65, and having according to said Plat the following metes and bounds to-wit:

BEGINNING at an iron pin at the joint front corner of Lots 65 & 66 and running thence along the lines of Lot 66 S. 49 - 15 E. 83.2 ft.; thence continuing along the line of Lot 66 N. 88-15 E. 92.3 ft. to the joint rear corner of Lots 65 & 66; thence along the line of Lot 65 N. 57 - 37 E. 95.2 ft. to an iron pin on the West side of Helen St.; thence along the West side of Helen St., N. 34-38 W. 62.9 ft.; thence continuing along the line of said street N. 61 - 40 W. 76 ft. to a point at the intersection of Helen Street and Forrest Park Drive; thence following the intersection of Helen Street and Forrest Park Drive, the chord of which is S. 83 - 28 W. 41 ft. to a point on the Southeast side of Forrest Park Drive; thence along the Southeast side of Forrest Park Drive 143.20 ft. to the beginning corner.

The above described property is the same conveyed to the Grantor herein by deed of Lon S. Alexander, Sr., and Norma J. Alexander, dated May 28, 1957 and recorded in the R. M. C. Office for Greenville County, S. C., in Deed Book 577 at page 379. This lot is conveyed subject to restrictions setforth in Deed Book 512 at page 357.
