That I, Walter C. Chapman, in consideration of the sum of Seven Hundred and No/100 (\$700.00) and assumption of mortgage to the grantor(s) in hand paid at and before the sealing of these presents by the grantee(s) (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said Theodore B. and Ellen V. Mitzner, their heirs and assigns forever:

All that piece, parcel or lot of land situate, lying and being in Greenville County, State of South Carolina, on the Southeastern side of Heard Drive and being known and designated as Lot No. 48 Belmont Heights, as shown on plat thereof recorded in the R. M. C. Office for Greenville County, State of South Carolina, in plat book "GG" at Pages 54 and 55, and having according to said plat the following metes and bounds, to-wit:

BEGINNING at an iron pin on the Southeastern side of Heard Drive at joint front corner of Lots Nos. 48 and 49 and running thence along said Drive N. 40-49 E. 60.6 feet to an iron pin; thence continuing with said Drive N. 46-08 E. 44.4 feet to an iron pin at joint front corner of Lots Nos. 47 and 48; thence along the joint line of said lots S. 45-18 E. 149.8 feet to an iron pin; thence S. 33-18 W. 65 feet to an iron pin; thence N. 59-44 W. 165 feet to the point of beginning.

The above is the same property conveyed to the grantor by Cely Bros. Lumber Company by its deed dated September 16, 1955.

As part of the consideration of this deed the grantees assume and agree to pay the balance due on a note and mortgage given by the grantor to C. Douglas Wilson & Co. dated September 16, 1955 and recorded in the R. M. C. Office for Greenville County in Mortgage Book 652, at Page 173, the balance now due and owing being \$11,096.00.

TOGETHER with all and Singular the Rights, Members, Hereditaments and Appurtenances to the said premises belonging, or in anywise incident or appertaining.

TO HAVE AND TO HOLD all and singular the said Premises before mentioned unto the grantee(s) hereinabove named, and their Heirs and Assigns forever.

And the grantor(s) do(es) hereby bind the grantor(s) and the grantor's(s) Heirs, Executors and Administrators to warrant and forever defend all and singular the said premises unto the grantee(s) hereinabove named, and the grantee's(s) Heirs and Assigns against the grantor(s) and the grantor's(s) Heirs and against every person whomsoever lawfully claiming or to claim the same or any part thereof.
