That I, C. E. HARRIS in the State aforesaid, in consideration of the sum of One Hundred Twenty-two and No/100----- DOLLARS,

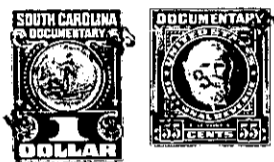
