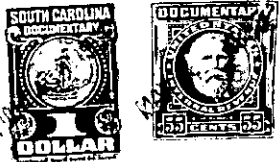
That I, C. F. Putman, in the State aforesaid, in consideration of the sum of (\$310.00) Three Hundred Ten and NO/100 DOLLARS,
