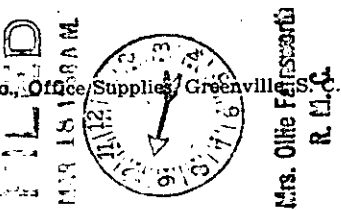

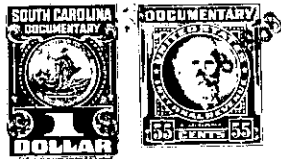

Rochester, her heirs and assigns forever:

ALL that piece, parcel or lot of land in the State and County aforesaid, being known and designated as Lot No. 105, as shown on a Plat by Dalton & Neves, Engineers, dated 1943, entitled "Estate of H.
