Costner, his heirs and assigns, forever,

All that piece, parcel and lot of land in Gantt Township, Greenville County, State of South Carolina, near the City of Greenville, being known as Lot No. 323 Pine Creek Drive, according to a survey of Belle Meade Subdivision (Section 3) made by Piedmont Engineering Service and recorded in the R. M. C. Office for Greenville County S. C. in Plat Book "GG" at Page 187. Said lot is more particularly described as follows:

BEGINNING at an iron pin on the east side of Pine Creek Drive at the joint front corner of Lots 322 and 323 and running along the line of Lot 322 S. 57-52 E. 130 feet to an iron pin, joint rear corner of Lots 322 and 323; thence along the rear line of Lots 306 and 307 N. 32-08 E. 81 feet to an iron pin, joint rear corner of Lots 323 and 324; thence along the line of Lot 324 N. 57-52 W. 130 feet to an iron pin on Pine Creek Drive, joint front corner of Lots 323 and 324; thence along Pine Creek Drive S. 32-08 W. 81 feet to an iron pin, the beginning corner.

Subject, however, to those protective covenants and restrictions and the easements reserved therein, as recorded in the R. M. C. Office for Greenville County S. C. in Deed Book 552, at Page 473.

The grantee is to pay 1958 taxes.
