All that piece, parcel, or lot of land situate, lying and being in the County of Greenville, State of South Carolina on the eastern side of Alice Avenue and being known and designated as Lot No. 10 on plat of property of B. E. Waldrop, dated Feb. 1924, prepared by R. E. Dalton and recorded in the R. M. C. Office for Greenville County in Plat Book "D" at Page 247, and having, according to said Plat, the following metes and bounds, to-wit:

BEGINNING at an iron pin on the eastern side of Alice Avenue at the joint front corner of Lots 10 and 11 and running thence along the eastern side of said Avenue, N. 13-15 W. 50 feet to an iron pin, joint front corner of Lots 9 and 10; thence along the joint line of Lots 9 and 10, N. 89-39 E. 122.6 feet to an iron pin; thence S. 13-41 E. 50 feet to an iron pin, joint rear corner of Lots 10 and 11; thence along the joint line of said lots, S. 89-37 W. 122.9 feet to the point of beginning.

The above property was previously conveyed by the grantor to the grantee on February 13, 1952, in Deed Book 457 at page 150, and this deed is executed in order to correct certain irregularities contained in the aforementioned deed.

And the grantor(s) do(es) hereby bind the grantor(s) and the grantor's(s) Heirs, Executors and Administrators to warrant and forever defend all and singular the said premises unto the grantee(s) hereinabove named, and the grantee's(s) Heirs and Assigns against the grantor(s) and the grantor's(s) Heirs and against every person whomsoever lawfully claiming or to claim the same or any part thereof.
