to the grantor(s) in hand paid at and before the sealing of these presents by the grantee(s) (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said J. E. Meadors, his Heirs and Assigns:

All that piece, parcel or lot of land situate, lying and being near the City of Greenville, County of Greenville, State of South Carolina, being known and designated as Lot No. 2, Section IV, Lake Forest, as per plat thereof recorded in the RMC Office for Greenville County, South Carolina, in Plat Book JJ, page 115, and having, according to said plat, the following metes and bounds, to wit:

BEGINNING at an iron pin on the Southwesterly side of Shannon Drive; joint corner Lots 1 and 2 and running thence S. 59-25 W. 154.9 feet to an iron pin; thence S. 30-35 E. 169.8 feet to an iron pin; thence S. 27-51 W. 23.9 feet to a point on the high water mark of Lake Fairfield; thence along the line of the high water mark of Lake Fairfield S. 42-29 E. 38 feet to a point; thence N. 32-53 E. 87.4 feet to a point; thence N. 53-51 E. 100 feet to an iron pin on Shannon Drive; thence along Shannon Drive N. 36-09 W. 106 feet to a point; thence continuing along Shannon Drive N. 30-35 W. 65 feet to an iron pin, the point of beginning.
