Know All Men by These Presents:

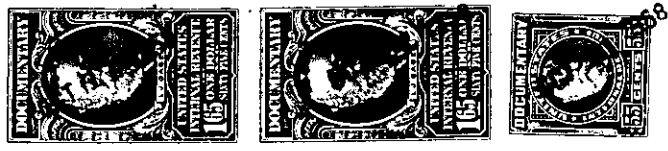

TIMMONS, JR., in the State aforesaid, in consideration of the sum of THREE THOUSAND TWO HUNDRED FORTY-FIVE AND NO/100-- DOLLARS, (\$3,245.00) to the grantor(s) in hand paid at and before the sealing of these presents by the grantee(s) (the receipts whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said R. W. MANLEY, His Heirs and Assigns:

ALL that certain piece, parcel or lot of land in Butler Township, Greenville County, State of South Carolina, near the City of Greenville, and being known and designated as Lot Number 124 of a subdivision known as McSwain Gardens, Section 2, a plat of which is of record in the R. M. C. Office for Greenville County in Plat Book LL at Page 137, and having the following metes and bounds, to wit:

BEGINNING at a point on the Southeastern side of Beaufort Street at the joint front corner of Lots 124 and 125 and running thence S 15-53 E 225 feet to a point at the joint rear corner of Lots 124 and 125; thence S 83-07 W 204.6 feet to a point on the Eastern side of Beaufort Street at the joint corner of Lots 123 and 124; thence with the Eastern side of Beaufort Street N 08-01 E 31.1 feet to a point; thence continuing with the Eastern side of Beaufort Street N 06-05 E 102.9 feet to a point; thence following the curvature of Beaufort Street N 35-14 E 87.3 feet to a point; thence with the Southeastern side of Beaufort Street N 64-19 E 84.1 feet to the point of beginning.

THIS deed is executed subject to existing and recorded restrictions and rights-of-way.

TO HAVE AND TO HOLD all and singular the said Premises before mentioned unto the grantee(s) hereinabove named and His Heirs and Assigns forever.

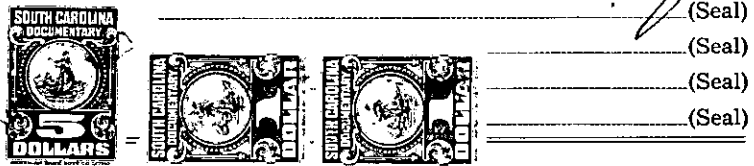
