All that piece, parcel or lot of land situate, lying and being near the City of Greenville, County of Greenville, State of South Carolina, being known and designated as Lot 173, Section III, Lake Forest Subdivision, as per plat thereof recorded in the RMC Office for Greenville County, South Carolina in Plat Book GG, page 77, and having, according to said plat, the following metes and bounds, to wit:
