That I, Thomas A. Corley, in the State aforesaid, in consideration of the sum of One and No/100 (\$1.00) DOLLARS,

to the grantor(s) in hand paid at and before the sealing of these presents by the grantee(s) (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said Gladys H. Corley, her Heirs and Assigns forever:

All that piece, parcel or lot of land situate, lying and being in the County of Greenville, State of South Carolina, and being known and designated as Lot No. 117 of property of Super Highway Home Sites, as shown on plat thereof recorded in the R. M. C. Office for Greenville County in Plat Book "P", at Page 53 and having the following metes and bounds, to-wit:

BEGINNING at an iron pin on the eastern side of Broad Vista Boulevard at the joint front corner of Lots Nos. 116 and 117 and running thence along said Boulevard N. 13-20 W. 80 feet to an iron pin at joint front corner of Lots Nos. 117 and 118, which iron pin is 145.4 feet South of Dove Lane and running thence along the joint line of Lots 117, 118 and 119 N. 69-10 E. 230.9 feet to an iron pin in the center of a 5-foot utility easement; thence S. 2-0 W. 135 feet to an iron pin joint rear corner of Lots Nos. 116 and 117; thence along the joint line of said Lots S. 83-0 W. 194.8 feet to the point of beginning.
