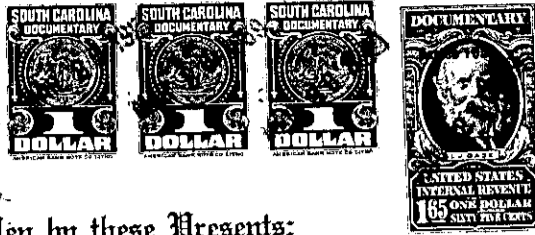

Know All Men by these Presents:

That H. C. FOWLER AND SYBIL R. FOWLER in the State aforesaid, in consideration of the sum of One Thousand One Hundred Twenty-Five and No/100 -DOLLARS,

to the grantor(s) in hand paid at and before the sealing of these presents by the grantee(s) (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said G. T. Simpson, his heirs and assigns forever:

An undivided one-half interest in and to: All that certain piece, parcel or lot of land in the State of South Carolina, County of Greenville, on the southeastern side of Cammer Avenue in the City of Greenville, being shown and designated as Lot 32 on plat of property of G. F. Cammer recorded in Plat Book L, Page 115, and having according to said plat the following metes and bounds, to-wit:

BEGINNING at an iron pin on the southeastern side of Cammer Avenue at joint front corner of Lots 31 and 32 and running thence with the line of Lot 31 S. 48-48 E. 240.5 feet to an iron pin at rear line of Lot 45; thence with the rear line of Lots 45 and 44 N. 35-07 E. 67.4 feet to an iron pin at rear corner of Lot 33; thence with the line of Lot 33 N. 48-48 W. 233.3 feet to pin on Cammer Avenue; thence with the southeastern side of Cammer Avenue S. 41-12 W. 67 feet to the point of beginning.

Being the same premises conveyed to the grantors by deed recorded in Deed Book 545, Page 30.

And the grantor(s) do(es) hereby bind the grantor(s) and the grantor's(s') Heirs, Executors and Administrators to warrant and forever defend all and singular the said premises unto the grantee(s) hereinabove named, and the grantee's(s') Heirs and Assigns against the grantor(s) and the grantor's(s') Heirs and against every person whomsoever lawfully claiming or to claim the same or any part thereof.
