I, E. INMAN, Master in and for the County aforesaid, SEND GREETING:

WHEREAS, Virginia T. Daniel, as Executrix of the estate of Emmie R. Thackston and Administratrix CTA of the Estate of Annie T. Goodlett

on or about the 27th day of March in the year of our Lord nineteen hundred and fifty-nine exhibited her complaint in the Court of Common Pleas, for the County aforesaid, against Patricia Andrena Thackston Ray and Jane Parker Thackston

HAVE GRANTED, conveyed and released, and by these presents, DO GRANT, convey and release unto the said Wheeler M. Thackston

All the right, title and interest of the minor Defendants, Patricia Andrena Thackston Ray and Jane Parker Thackston, in and to the following described real estate:

"All that piece, parcel or tract of land, situate, lying and being on the westerly side of Buncombe Road near the City of Greenville, County of Greenville, State of South Carolina, and being shown on a plat of the Thackston Estate as Tract No. 2, and having the following metes and bounds to-wit:

BEGINNING at a pin in the center of Buncombe Road at the corner of the property now owned by Wheeler M. Thackston; and running thence through Buncombe Road S. 11-57 W. 150 feet to a point; thence continuing through the center of Buncombe Road S. 9-45 W. 150 feet to a pin; thence along the line of Tract No. 1 N. 83-36 W. 747-4 feet to a stone; thence along the line of the property now owned by Wheeler M. Thackston N. 74-20 E. 797.7 feet to a point along the right-of-way along Buncombe Road; thence in a northeasterly direction 37.5 feet to the point of beginning; being triangular in shape and containing 2.45 acres to the Buncombe Road right-of-way.
