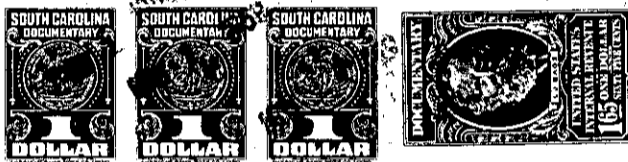
All that certain piece, parcel or lot of land lying and being on the westerly side of Fleetwood Drive, near the City of Greenville, S. C., being shown as Lot No. 43 on the plat of Magnolia Acres as recorded in the RMC Office for Greenville County, S. C. in Plat Book GG, page 133, and having according to said plat the following metes and bounds, to-wit:

BEGINNING at an iron pin on the westerly side of Fleetwood Drive at a point 342 feet northeast of the northerly corner of the intersection of Fleetwood Drive and Cool Brook Drive, said pin being the joint front corner of Lots 43 and 44, and running thence along the joint line of said lots N 79-51 W 163.2 feet to an iron pin; thence N 00-15 E 91.1 feet to an iron pin, joint rear corner of Lots 42 and 43; thence along the joint line of said lots S 79-51 E 178.9 feet to an iron pin on the westerly side of Fleetwood Drive; thence along the westerly side of Fleetwood Drive S 10-09 W 90 feet to the point of beginning. A portion of the rear of this lot is subject to the drainage easement shown on the recorded plat.
