to the grantor(s) in hand paid at and before the sealing of these presents by the grantee(s) (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said grantee(s) Hazel C. Edwards, her heirs and assigns forever:

All that certain piece, parcel or lot of land, located in Greenville County, O'neal Township, State of South Carolina, and shown and designated as Lot No. 14, on plat of property of D.E. Camp, said plat being recorded in the office of RMC in Volume FF at page 537, and being described as follows:
