All that certain piece, parcel or lot of land situate, lying and being near the City of Greenville, County of Greenville, State of South Carolina, and known and designated as lot #20, on the southern side of Forestwood Drive, part of Broadleaf Forest, according to survey by Jones and Sutherland, August 1958, plat of which is recorded in the R.
