to the grantor(s) in hand paid at and before the sealing of these presents by the grantee(s) (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said A. L. Tinsley, his heirs and assigns forever.

All that certain piece, parcel or lot of land in the County of Greenville, State of South Carolina, on the northerly side of the Old Easley Bridge Road, and being shown and designated as Lot No. 5 on plat of "PLAINVIEW HEIGHTS", recorded or to be recorded in the RMC Office for Greenville County, South Carolina, in Plat Book QQ, Page 23, and being more recently shown on survey of said lot prepared by Jones and Sutherland, Engineers, on March 6, 1959, revised May 29, 1959 to show courses and distances of Lot No. 5, and having the following metes and bounds, to-wit:

Beginning at an iron pin on northeast side of Plainview Drive, joint front corners of Lots Nos. 4 and 5; thence N. 21-57 E. 188.9 feet to iron pin, joint rear corners of Lots Nos. 4 and 5; thence N. 66-05 W. 91.9 feet to iron pin, joint rear corners of Lots Nos. 5 and 6; thence S. 22-58 W. 187.2 feet to iron pin, joint front corners of Lots 5 and 6; thence with northeast side of Plainview Drive S. 67-02 E. 51.5 feet to iron pin; thence with northeast side of Plainview Drive S. 61-23 E. 38.5 feet to joint front corners of Lots 4 and 5, place of beginning.

The property herein conveyed is subject to the restrictions applicable thereto recorded in the RMC Office for Greenville County in Deed Book 610, Page 311, and subject to setback lines as shown on plat of March 6, 1959, hereinabove referred to, and further subject to utility easements and rights of way of record.
