in consideration of the sum of ELEVEN THOUSAND AND NO/100-----(\$11,000.00)-----DOLLARS,

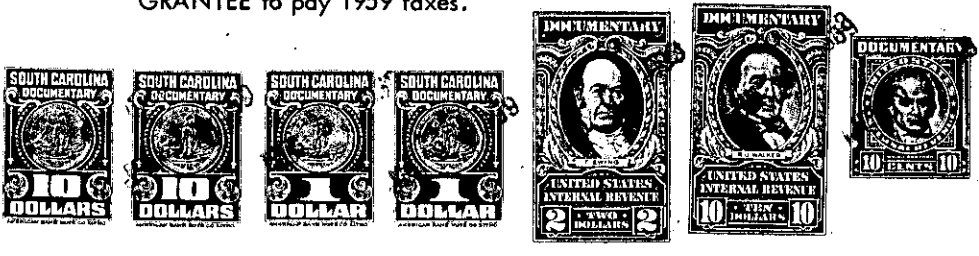

WILLIAM W. RICHARDSON, His Heirs and Assigns:

ALL that certain piece, parcel or lot of land in Austin Township, Greenville County, State of South Carolina, near Mauldin, and being known and designated as Lot Number 52 of a subdivision known as Glendale, a plat of which is of record in the R. M. C. Office for Greenville County in Plat Book GG at Pages 32-33, and having the following metes and bounds, to wit:

BEGINNING at a point on the Northern side of Drury Lane at the joint front corner of Lots 51 and 52 and running thence N 11-16 E 155 feet to a point at the joint rear corner of Lots 51 and 52; thence N 65-05 W 97.8 feet to a point at the joint rear corner of Lots 52 and 53; thence S 11-16 W 178 feet to a point on the Northern side of Drury Lane at the joint front corner of Lots 52 and 53; thence with the Northern side of Drury Lane S 78-44 E 95 feet to the point of beginning.
