to it in hand duly paid at and before the sealing and delivery of these presents by the grantee(s) hereinafter named, (the receipt whereof is hereby acknowledged), has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto RALPH H. CUTHBERTSON AND GAYNELLE W. CUTHBERTSON:

All that certain piece, parcel or lot of land situate, lying and being at the Northwestern corner of the intersection of Dundee Lane and Kensington Road, in Paris Mountain Township, near the City of Greenville, in Greenville County, State of South Carolina, being known and designated as Lot No. 33 of a subdivision known as Stratford Forest, and having according to a plat of said subdivision prepared by Piedmont Engineering Service, dated February 25, 1957, and recorded in the R.M.C. Office for Greenville County, S. C. in Plat Book KK at page 89, the following metes and bounds:

BEGINNING at an iron pin on the Western side of Dundee Lane at the joint front corner of Lots Nos. 33 and 34 and running thence with the line of Lot 34 S. 81-03 W. 340.3 feet to an iron pin in the subdivision property line; thence with the said subdivision property line S. 9-45 E. 231.6 feet to an iron pin on the Northern side of Kensington Road; thence with the Northern side of Kensington Road N. 81-32 E. 180 feet to an iron pin; thence continuing with the Northern side of Kensington Road N. 72-27 E. 200 feet to an iron pin; thence with the curve of the intersection of Kensington Road and Dundee Lane, the chord of which is N. 20-50 E., 34.8 feet to an iron pin on the Western side of Dundee Lane; thence with the Western side of Dundee Lane N. 27-30 W. 182.6 feet to the point of beginning.

This conveyance is made subject to "Protective Covenants Applicable to Stratford Forest" recorded in the R.M.C. Office for Greenville County, South Carolina, in Deed Book 578 at page 1 and to drainage and utility easements, if any, affecting said lot.

This is a portion of the property conveyed to the grantor herein by deed of Furman University, dated November 13, 1956, and recorded in the office of the R.M.C. for Greenville County, in Deed Book 567 at page 397.
