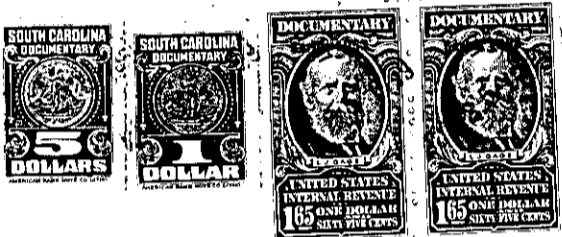
That DERBY HEIGHTS INC. in the State aforesaid, in consideration of the sum of THREE THOUSAND AND NO/100 DOLLARS,
