That I, William L. Costner, in the State aforesaid, in consideration of the sum of Sixty One Hundred Twelve and 50/100 (\$6112.50)----- DOLLARS, and assumption of mortgage to the grantor(s) in hand paid at and before the sealing of these presents by the grantee(s) (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said

George E. Wickman and Betty L. Wickman, their Heirs and Assigns forever:

All that piece, parcel or lot of land situate, lying and being in Gantt Township, Greenville County, State of South Carolina, on the northwestern side of Chesterfield Road and being known and designated as Lot No. 312 of Belle Meade, Section 3, as shown on plat thereof recorded in the R. M. C. Office for Greenville County in Plat Book "GG", at Page 187 and having, according to said plat, the following metes and bounds, to-wit:

BEGINNING at an iron pin on the northwestern side of Chesterfield Road at the joint front corner of Lots Nos. 311 and 312 and running thence along said Road, S. 32-08 W. 85 feet to an iron pin; thence along the joint line of Lots Nos. 313 and 312, N. 57-52 W. 130 feet to an iron pin; thence N. 32-08 E. 85 feet to an iron pin; thence along the joint line of Lots Nos. 311 and 312, S. 57-52 E. 130 feet to the point of beginning.

The above is the same property conveyed to the grantor by Joe J. Faress by his deed dated January 23, 1959 and recorded in Deed Book 615, at Page 229.

As part of the consideration of this conveyance the grantees assume and agree to pay the balance due on the mortgage given by the grantor to Fidelity Federal Savings and Loan Association recorded in the R. M. C. Office for Greenville County in Mortgage Book 785, at Page 120, the balance now due and owing being \$12,562.50.

TOGETHER with all and Singular the Rights, Members, Hereditaments and Appurtenances to the said premises belonging, or in anywise incident or appertaining.

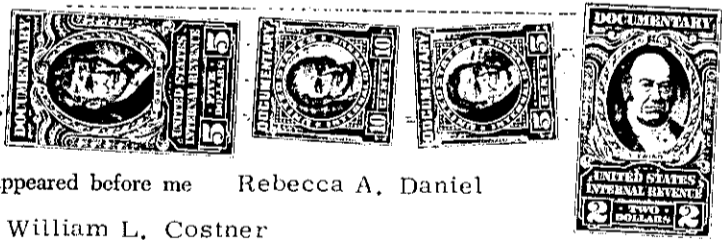
TO HAVE AND TO HOLD all and singular the said Premises before mentioned unto the grantee(s) hereinabove named, and their Heirs and Assigns forever.
