to the grantor(s) in hand paid at and before the sealing of these presents by the grantee(s) (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said James G. Abbott, his heirs and assigns forever

All that certain piece, parcel or lot of land in the County of Greenville, State of South Carolina, being on the west side of the Old Easley Bridge Road, and being shown and designated as Lots Nos. 36 and 37 on plat of "PLAINVIEW HEIGHTS" recorded or to be recorded in the RMC Office for Greenville County, South Carolina, in Plat Book QQ, Page 23, and being more recently shown on survey of said lots completed by Jones and Sutherland, Engineers on June, 1959, said lots having the following metes and bounds, to-wit:

Beginning at an iron pin on the east side of Plainview Drive, joint front corners of Lots Nos. 35 and 36, and running thence with the east side of Plainview Drive, S. 11-05 E. 100 feet to an iron pin, joint front corners of Lots Nos. 36 and 37; thence with the east side of Plainview Drive, S. 11-05 E. 100 feet, joint front corners of Lots Nos. 25 and 37; thence N. 78-55 E. 60 feet to an iron pin, joint rear corners of Lots Nos. 25 and 26; thence with the rear line of Lot No. 26, N. 78-55 E. 80.3 feet to an iron pin, joint rear corners of Lots Nos. 26 and 27; thence with the rear line of Lot No. 27, N. 22-55 E. 97.2 feet to an iron pin, joint rear corners of Lots Nos. 27 and 28; thence N. 10-20 W. 19.7 feet to an iron pin, joint rear corners of Lots Nos. 36 and 37; thence N. 10-20 W. 20.3 feet to an iron pin on the rear line of Lot No. 36; thence N. 10-20 W. 79.5 feet to an iron pin, joint rear corners of Lots Nos. 35 and 36; thence with the south line of Lot No. 35, S. 78-55 W. 196.9 feet to an iron pin on the east side of Plainview Drive, the point of beginning.

The property herein conveyed is subject to the restrictions applicable thereto recorded in the RMC Office for Greenville County in Deed Book 610, Page 311 and subject to setback lines as shown on plat of June, 1959, hereinabove referred to and further subject to utility easements and rights of way of record.
