to the grantor(s) in hand paid at and before the sealing of these presents by the grantee(s) (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said Edgar W. Teasley, his heirs and assigns forever:

All that certain piece, parcel or lot of land lying and being on the easterly side of Cool Brook Drive, near the City of Greenville, S. C., being shown as Lot No. 50 on the plat of Magnolia Acres as recorded in the RMC Office for Greenville County, S. C. in Plat Book GG, page 133, and having according to said plat the following metes and bounds, to-wit:

BEGINNING at an iron pin on the easterly side of Cool Brook Drive at a point 492.4 feet north of the northerly corner of the intersection of Cool Brook Drive and Fleetwood Drive, said pin being the joint front corner of Lots 49 and 50, and running thence along the joint line of said lots N 85-04 E 187.6 feet to an iron pin; thence along the joint line of Lot 50 with Lots 43 and 42 N 00-15 E 132.3 feet to an iron pin, joint rear corner of Lots 50 and 51; thence along the joint line of said lots S 68-20 W 215.4 feet to an iron pin on the easterly side of Cool Brook Drive; thence along the easterly side of Cool Brook Drive on a curve, the chord of which is S 10-33 E 70 feet to the point of beginning.

The above lot constitutes a part of the property conveyed to the grantor herein by the deed recorded in Deed Book 562, page 91, and this conveyance is made pursuant to the authority and powers granted the Trustee in said deed.
