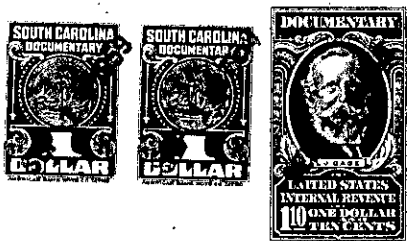
Know All Men by These Presents:

Office for Greenville County in Plat Book TT, at page 108, and having, according to said plat, the following metes and bounds:

BEGINNING at a pin, corner of Lot 1, on the northern side of Rockvale Drive, and running thence with Rockvale Drive, S. 84-03 W., 75 feet to a pin; thence with the line of Lot 3, N. 7-41 W., 160.7 feet to a pin; thence N. 83-30 E., 40 feet to a pin; thence S. 69 E., 39.3 feet to a pin; thence with the line of Lot 1, S. 7-38 E., 142.9 feet to the beginning.
