W. W. Burgess, his heirs and assigns: All that piece, parcel, or lot of land situate, lying and being in Greenville Township, Greenville County, South Carolina, in the F. W. Poe Manufacturing Company Village, and being known and designated as Lot No. 48, Section 1, as shown on plat of property of the F. W. Poe Manufacturing Company, recorded in Plat Book Y at pages 26-31, and according to said plat, having the following metes and bounds, to-wit:

BEGINNING at an iron pin at the joint front corner of Lots Nos. 48 and 49, and running thence N. 40-58 W., 75 feet to an iron pin, joint front corner of Lots Nos. 47 and 48; thence with the line of said lots N. 49-26 E., 100 feet to an iron pin, the joint rear corner of Lots Nos. 47, 48, 56 and 57; thence with the rear line of Lots Nos. 48 and 56 S. 40-58 E., 75 feet to an iron pin, the joint rear corner of Lots Nos. 48, 49, 55 and 56; thence with the line of Lots Nos. 48 and 49 S. 49-26 W., 100 feet to the point of beginning, and being one of two lots conveyed to grantor by deed dated August 20, 1951, recorded in Deed Book 472, Page 18.
