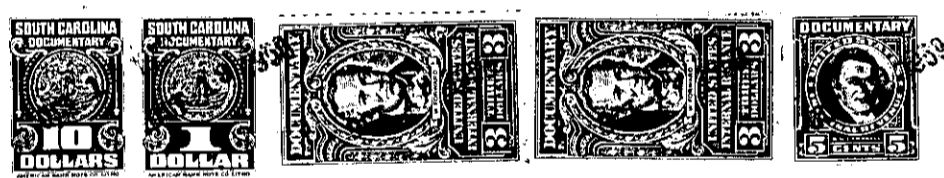

to it in hand duly paid at and before the sealing and delivery of these presents by the grantee(s) hereinafter named, (the receipt whereof is hereby acknowledged), has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto ALVIN H. RAMPEY:

All that certain piece, parcel or lot of land situate, lying and being at the Southwestern corner of the intersection of South Warwick Road and Dundee Lane, in Paris Mountain Township, near the City of Greenville, in Greenville County, State of South Carolina, being known and designated as Lot No. 37 of a subdivision known as Stratford Forest, and having according to a plat of said subdivision prepared by Piedmont Engineering Service, dated February 25, 1957, and recorded in the R.M.C. Office for Greenville County, South Carolina, in Plat Book KK at page 89, the following metes and bounds:

BEGINNING at an iron pin on the Western side of Dundee Lane at the joint front corner of Lots Nos. 36 and 37, and running thence with the line of Lot No. 36 N. 74-07 W. 268.8 feet to an iron pin at the joint rear corner of Lots Nos. 37 and 38; thence with the line of Lot No. 38 N. 13-20 E. 225 feet to an iron pin on the Southern side of South Warwick Road; thence with the Southern side of South Warwick Road S. 68-52 E. 165 feet to an iron pin; thence with the curve of the intersection of South Warwick Road and Dundee Lane, the chord of which is S. 32-16 E., 41.6 feet to an iron pin on the Western side of Dundee Lane; thence with the Western side of Dundee Lane S. 8-47 E. 200 feet to the point of beginning.

This conveyance is made subject to "Protective Covenants Applicable to Stratford Forest", recorded in the R.M.C. Office for Greenville County, South Carolina, in Deed Book 578 at page 1, and to drainage and utility easements, if any, affecting said lot.

This is a portion of the property conveyed to the grantor herein by deed of Furman University, dated November 13, 1956, and recorded in the R.M.C. Office for Greenville County, South Carolina, in Deed Book 567 at page 397.

 To have and to hold all and singular the premises before mentioned unto the grantee(s) hereinabove named, his heirs and assigns forever.

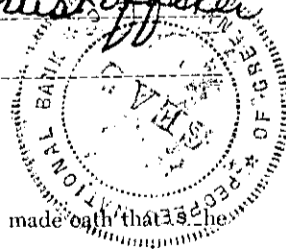
