Know All Men by These Presents:

That I, WILLIAM R. TIMMONS, JR., in the State aforesaid, in consideration of the sum of ONE THOUSAND NINE HUNDRED SEVENTY AND NO/100-----DOLLARS, (\$1,970.00) to the grantor(s) in hand paid at and before the sealing of these presents by the grantee(s) (the receipts whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said WANDA E. McCALL, Her Heirs and Assigns:

ALL that certain piece, parcel or lot of land in Butler Township, Greenville County, State of South Carolina, near the City of Greenville, and being known and designated as Lot Number 21 of a sub-division known as McSwain Gardens, a plat of which is of record in the R. M. C. Office for Greenville County in Plat Book GG at Page 75, and having the following metes and bounds, to wit:

BEGINNING at a point on the Northeastern side of Shannon Drive at the joint corner of Lots 21 and 22 and running thence N 43-40 E 140 feet to a point at the joint rear corner of Lots 21, 22 and 29; thence N 13-12 W 128.7 feet to a point on the Southern side of Astor Street at the joint corner of Lots 21 and 29; thence with the Southern side of Astor Street S 76-48 W 112.3 feet to a point; thence continuing with the Southern side of Astor Street S 60-29 W 90.9 feet to a point; thence following the curvature of the Southeastern intersection of Astor Street with Shannon Drive (the chord of which is S 01-49 W 38.5 feet) to a point; thence with the Northeastern side of Shannon Drive S 39-15 E 59.8 feet to a point; thence continuing with the Northeastern side of Shannon Drive S 51-35 E 75.3 feet to a point; thence still continuing with the Northeastern side of Shannon Drive S 46-20 E 35.6 feet to the point of beginning.

THIS deed is executed subject to existing and recorded restrictions and rights-of-way.

And the grantor(s) do(es) hereby bind the grantor(s) and the grantor's(s') Heirs, Executors and Administrators to warrant and forever defend all and singular the said premises unto the grantee(s) hereinabove named, and the grantee's(s') Heirs and Assigns against the grantor(s) and the grantor's(s') Heirs and against every person whomsoever lawfully claiming or to claim the same or any part thereof.
