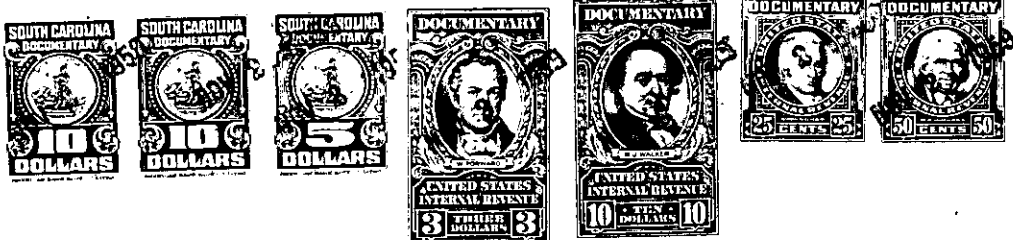
That I, Hubert E. Thomas in the State aforesaid,
