Know All Men by These Presents:

That I, Harry Cayson Dunagan

in the State aforesaid,

in consideration of the sum of Four thousand and 00/100 (\$4,000.00)----- DOLLARS,
and assumption of mortgage hereinafter set out.
to the grantor(s) in hand paid at and before the sealing of these presents by the grantee(s) (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said Frank A. Odom and Alberta D. Odom, their heirs and assigns for ever:

All that piece, parcel or lot of land situate, lying and being in the County of Greenville, State of South Carolina on the northeastern corner of the intersection of Galphin Drive and Cyrus Court and being known and designated as Lot No. 7 of Property of John G. Wilson as shown on plat thereof prepared by Dalton & Neves January, 1954 and recorded in the R. M. C. Office for Greenville County in Plat Book "W", at Page 163 and having according to said plat the following metes and bounds, to-wit:

BEGINNING at an iron pin on the northern side of Cyrus Court, joint front corner of Lots Nos. 6 and 7 and running thence along said Court N. 60-09 W. 145 feet to an iron pin; thence with the curvature of the intersection of Galphin Drive and Cyrus Court 33.4 feet, the chord of which is N. 12-09 W.; thence along the eastern side of Galphin Drive N. 35-51 E. 95 feet to an iron pin, joint corner of lots Nos. 7 and 8; thence along the joint line of said lots S. 60-18 E. 160 feet to an iron pin, joint rear corner of Lots Nos. 6 and 7; thence along the joint side line of said lots S. 31-05 W. 119.7 feet to the point of beginning.

The above is the same property conveyed to the grantor by deed of G. F. Wakefield, dated July 16, 1956, and recorded in the R. M. C. Office for Greenville County in Deed Book 557 at Page 130. As part of the consideration hereof, the Grantees agrees to pay and assume that certain mortgage heretofore executed by the Grantor in behalf of the Fidelity Federal Savings and Loan Association, Greenville, South Carolina upon which there is a present balance in the approximate amount of \$12457.55.

TOGETHER with all and Singular the Rights, Members, Hereditaments and Appurtenances to the said premises belonging, or in anywise incident or appertaining.

TO HAVE AND TO HOLD all and singular the said Premises before mentioned unto the grantee(s) hereinabove named, and their Heirs and Assigns forever.

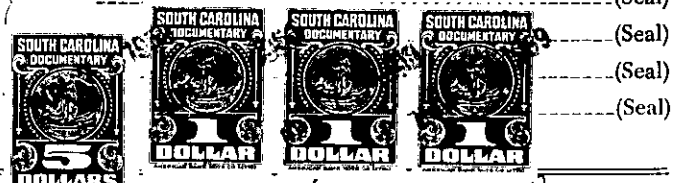

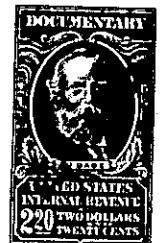
