WHEREAS, A. W. Hill County Treasurer of said Greenville County, did issue his warrants directed to the Delinquent Tax Collector for said County and State by authority of the acts of the General Assembly of South Carolina and the statute laws of said State, against E. C. Surett

defaulting taxpayer(s) of said County, strictly charging and commanding said Delinquent Tax Collector of said County to levy by distress and sale of the lands of the said

tax defaulter(s), the sum of Seventeen & 62/100 Dollars

including the penalties on said tax execution(s) for the year(s) 1953

together with charges and costs thereof; and

WHEREAS, by virtue and authority of said warrants George F. Miller the delinquent tax collector of the State and County aforesaid, did on the 4th day of September 19 58 seize and take exclusive possession of the said property against which said taxes were assessed and levied, as hereinafter described, and on Sales Day of the month of October during the usual hours of sale, after due advertisement, sell the same to M. O. Center and his heirs and assigns, the purchaser(s), hereinafter known as "grantee(s)," and the highest bidder at such sale, for the sum of Sixty Five & No/100 Dollars and gave a receipt for said purchase money to him; and

WHEREAS, more than twelve months have elapsed since the date of said sale, and the defaulting taxpayer(s), or any other party interested, have failed to redeem said land so sold for taxes;

NOW, THEREFORE, KNOW ALL MEN BY THESE PRESENTS That I, George F. Miller, Tax Collector of and for the County and State aforesaid, in consideration of the premises, and the sum of Sixty Five & No/100 Dollars to me paid by the said grantee(s), M. O. Center

have granted, bargained, sold and released, and by these presents do grant, sell, bargain and release unto the said grantee(s), M. O. Center

his heirs and assigns; All that piece, parcel or lot of land in Greenville County, State of South Carolina, known and designated as Lot No. 13, and a ten foot strip off of Lot No. 12, shown on plat of Summitt View, and having the following metes and bounds: Beginning at an iron pin joint corner with lot No. 14; thence along the line of Lot No. 13 and Lot No. 14, N. 39-30 E. 149 feet, more or less, to an iron pin in the joint line of lots No. 13 and 14; thence S. 58-35 E. along the rear line of Lot No. 13 and 10 feet along the rear line of Lot No. 12 and an aggregate distance of 53 feet to an iron pin; thence S. 39-30 W. 148 feet to an iron pin in the edge of Creole Street; thence with Creole Street N. 58-35 W. 60 feet to the beginning corner.
