All that parcel or lot of land lying and being in the County of Greenville, State of South Carolina, being designated as Lot No. 62 as shown on Plat No. Three, Cherokee Forest, prepared by J. Mac Richardson, R. L. S., in January, 1959, and recorded in the R. M. C. Office for Greenville County, South Carolina, in Plat Book QQ at pages 36 and 37, and having, according to said plat, the following metes and bounds:

BEGINNING at an iron pin on the Southern side of Roberta Drive at the joint front corner of Lots Nos. 61 and 62, and running thence with the line of Lot No. 61 S. 15-58 W. 210.3 feet to an iron pin with the line of the property now of Cunningham; thence with the line of said Cunningham property N. 73-45 W. 100 feet to an iron pin, the joint rear corner of Lots Nos. 62 and 63; thence with the line of Lot No. 62 N. 15-58 E. 209.7 feet to an iron pin on the Southern side of Roberta Drive; thence with the Southern side of Roberta Drive S. 74-02 E. 100 feet to the point of beginning.

The foregoing lot is subject to a drainage easement 5 feet wide at the rear of said lot.
