Know All Men by These Presents:

That I, William L. Costner, in consideration of the sum of Five Thousand Two Hundred Fifty Five and No/100----- DOLLARS, and assumption of mortgage to the grantor(s) in hand paid at and before the sealing of these presents by the grantee(s) (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said Bassell Blakesmith and Dorothy S. Blakesmith, their Heirs and Assigns forever:

All that piece, parcel or lot of land situate, lying and being in Gantt Township, Greenville County, State of South Carolina, on the northwestern side of Pine Creek Drive and being known and designated as Lot No. 240 of Belle Meade, Section 3, as shown on plat thereof recorded in the R. M. C. Office for Greenville County in Plat Book "GG", at Page 187 and having, according to said plat, the following metes and bounds, to-wit:

BEGINNING at an iron pin on the northwestern side of Pine Creek Drive at the joint front corner of Lots Nos. 240 and 241 and running thence along the joint line of said Lots, N. 57-52 W. 135 feet to an iron pin; thence S. 32-08 W. 80 feet to an iron pin; thence along the joint line of Lots Nos. 239 and 240, S. 57-52 E. 135 feet to an iron pin; thence along the northwestern side of Pine Creek Drive, N. 32-08 E. 80 feet to the point of beginning.

The above is the same property conveyed to the grantor by Derby Heights, Inc. by its deed dated August 12, 1959 and recorded in Deed Book 632, at Page 491.

As part of the consideration of this conveyance the grantees assume and agree to pay the balance due on the mortgage given by the grantor to Fidelity Federal Savings and Loan Association and recorded in the R. M. C. Office for Greenville County in Mortgage Book 801, at Page 64, the balance now due and owing being \$13,545.00.
