ISABELLE COXE CELY, her heirs and assigns forever:

AN undivided one-half interest in and to all that certain piece, parcel or lot of land in Greenville Township, Greenville County, State of South Carolina, in the City of Greenville, being designated as Lot No. 34 on plat of West End Land and Improvement Company, recorded in the R.M.C. Office for Greenville County in Plat Book "A" at page 153, and having, according to said plat, the following metes and bounds, to wit:

BEGINNING at an iron pin on the East side of Chicora Avenue at the joint front corner of Lots Nos. 34 and 35, and running thence with the line of Lot No. 35 N 79 E, 150 feet to an iron pin on rear line of Lot No. 54; thence with the line of Lot No. 54, S 11 E. 50 feet to an iron pin, joint rear corner of Lots Nos. 33 and 34; thence with the line of Lot No. 33, S 79 W, 150 feet to an iron pin on Chicora Avenue; thence with the East side of Chicora Avenue, N 11 W, 50 feet to the point of beginning.

The above property was conveyed to me by deed of Annie M. Craft, dated August 31, 1955, recorded in the R.M.C. Office for Greenville County, S. C., in Deed Book 534, page 435. On December 23 1959, I conveyed an undivided one-half interest in the above property to the grantee herein and the purpose of this deed is to convey to the grantee the remaining one-half interest in said property. See Deed recorded in the RMC Office for Greenville County, S.C. in Deed Book 641, page 205.

And the grantor(s) do(es) hereby bind the grantor(s) and the grantor's(s) Heirs, Executors and Administrators to warrant and forever defend all and singular the said premises unto the grantee(s) hereinabove named, and the grantee's(s) Heirs and Assigns against the grantor(s) and the grantor's(s) Heirs and against every person whomsoever lawfully claiming or to claim the same or any part thereof.
