to it in hand duly paid at and before the sealing and delivery of these presents by the grantee(s) hereinafter named, (the receipt whereof is hereby acknowledged), has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto G. E. TRIPP and ROBERT W. RAMSEY:

All that parcel or lot of land lying and being in the County of Greenville, State of South Carolina, being designated as Lot No. 43 as shown on Plat No. Three, Cherokee Forest, prepared by J. Mac Richardson, R. L. S., in January, 1959, and recorded in the R. M. C. Office for Greenville County, South Carolina, in Plat Book QQ at pages 36 and 37, and having, according to said plat, the following metes and bounds:

BEGINNING at an iron pin on the Northern side of Roberta Drive, the joint front corner of Lots Nos. 42 and 43, and running thence with the line of Lot No. 42 N. 6-15 E. 150.4 feet to an iron pin; thence along the line of Lot No. 40 S. 81-27 E. 155 feet to an iron pin; thence along a branch separating from Lot No. 44 S. 4-30 W. 115 feet to an iron pin; thence S. 22-40 E. 67 feet to an iron pin on the Northern side of Roberta Drive; thence with said side of Roberta Drive N. 74-02 W. 193.5 feet to an iron pin, the point of beginning.

The foregoing lot is subject to a five-foot drainage easement along its Eastern side adjoining Lot No. 44, as shown on said plat.

The foregoing lot is a portion of that conveyed to Wilkins Norwood & Company, Inc. by deed of Lucile L. Smith, et al, dated September 15, 1959, and recorded in the R. M. C. Office for Greenville County, South Carolina, in Deed Book 634 at page 188.
