All that certain piece, parcel or lot of land situate, lying and being on the southern side of Longwood Drive, near the City of Greenville, County of Greenville, State of South Carolina, being known and designated as lot #29, of a subdivision known as Thornwood Acres, Section 1, property of Williams Land Company, Inc., according to plat by Jones & Sutherland, Engineers, dated December 1958, plat of which is recorded in the R. M. C. Office for Greenville County, in Plat Book MM, at page 59, and according to said plat having the following metes and bounds:
