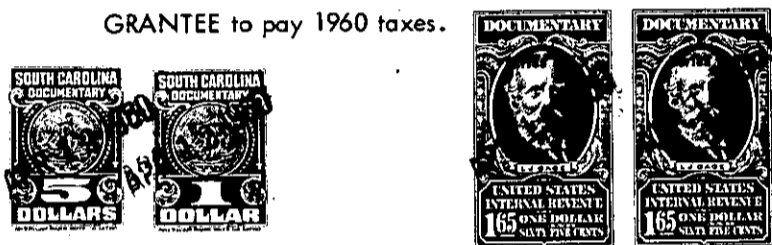

TIMMONS, JR., in the State aforesaid, in consideration of the sum of Two Thousand Seven Hundred Fifty and No/100-----(\$2,750.00)-----DOLLARS, to the grantor(s) in hand paid at and before the sealing of these presents by the grantee(s) (the receipts whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said J. A. CARSON, His Heirs and Assigns:

ALL that certain piece, parcel or lot of land in Butler Township, Greenville County, State of South Carolina, near the City of Greenville, and being known and designated as Lot Number 94 of a subdivision known as McSwain Gardens, according to a revised plat of Lots Numbers 90 through 94 which is of record in the R. M. C. Office for Greenville County in Plat-Book MM at Page 12, and having the following metes and bounds, to wit:

BEGINNING at a point on the Northeastern side of McSwain Drive at the joint front corner of Lots 93 and 94 and running thence N 66-05 E 176.1 feet to a point at the joint rear corner of Lots 93 and 94; thence S 22-10 E 95 feet to a point at the joint rear corner of Lots 94 and 95; thence S 67-37 W 175.65 feet to a point on the Northeastern side of McSwain Drive at the joint front corner of Lots 94 and 95; thence with the Northeastern side of McSwain Drive N 22-23 W 91 feet to the point of beginning.

THIS deed is executed subject to existing and recorded restrictions and rights-of-way.

GRANTEE to pay 1960 taxes.

TO HAVE AND TO HOLD all and singular the said Premises before mentioned unto the grantee(s) hereinabove named and His Heirs and Assigns forever.

And the grantor(s) do(es) hereby bind the grantor(s) and the grantor's(s') Heirs, Executors and Administrators to warrant and forever defend all and singular the said premises unto the grantee(s) hereinabove named, and the grantee's(s') Heirs and Assigns against the grantor(s) and the grantor's(s') Heirs and against every person whomsoever lawfully claiming or to claim the same or any part thereof.
