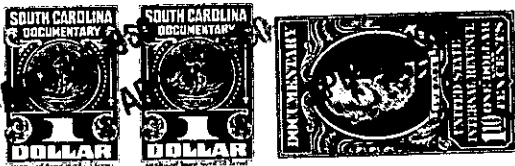
Know All Men by These Presents:

Harding, his heirs and assigns:

All that piece, parcel or lot of land situate, lying and being in Greenville County, South Carolina, being shown as Lot No. 49 on plat of Western Hills, recorded in Plat Book QQ at Pages 98-99, and, according to said plat, having the following metes and bounds, to-wit:

BEGINNING at an iron pin on the north side of Alice Farr Drive, at joint corner of Lots Nos. 49 and 50, and running thence with the line of said lots, N. 22-06 W., 184.9 feet; thence N. 74-48 E., 99.8 feet; thence S. 21-04 E., 173.7 feet to an iron pin on north side of Alice Farr Drive; thence with Alice Farr Drive, S. 68-56 W., 59.8 feet; thence still with said drive, S. 71-54 W., 20.2 feet to the point of beginning.

This conveyance is made subject to the recorded restrictions applicable to Western Hills and the easements as shown on said plat.
