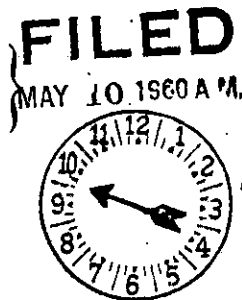

KNOW ALL MEN BY THESE PRESENTS That I, JOHN C. FISHER

in the State aforesaid, in consideration of the sum of ONE DOLLAR (\$1.00) and
Love and Affection ~~XXXXXX~~

to me in hand paid at and before the sealing of these presents
by KATHERINE E. FISHER,

(the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by
these presents do grant, bargain, sell and release unto the said KATHERINE E. FISHER,
her heirs and assigns,

all that piece, parcel or lot of land in Glassy Mountain Township, Greenville
County, State of South Carolina, adjoining the lands of Mildred E. Plemmons,
John C. Fisher, C.P. and Mary E. Hartman, and others, and more par
ticularly described by metes and bounds as follows:

BEGINNING on a nail in the center of the Dug Hill Road, said
nail being the Southwestern corner of the Mildred E. Plemmons South
Carolina property conveyed to her by the grantors herein by deed of
even date, said nail being also located in the line of the C.P. and
Mary E. Hartman property, and running thence with said Dug Hill Road
and the Hartman line four calls as follows: North 68 deg. 54 min.
West 100 feet to a nail; North 79 deg. 43 min. West 150 feet to a
nail, North 88 deg. 32 min. West 120 feet to a nail, and South 76 deg.
15 min. West 396.5 feet to an iron pin, a corner of the John C.
Fisher property; thence with the dividing line between the property
herein conveyed and the property retained by John C. Fisher North
14 deg. 51 min. East 239.3 feet to a stake in the North Carolina-
South Carolina State Line, said stake being the Southwestern corner
of the North Carolina property owned by Katherine E. Fisher; thence
with the North Carolina-South Carolina State Line and the Southern
line of the Katherine E. Fisher North Carolina property South 84 deg. 40
min. East 716.6 feet to a stake; thence South 12 deg. 41 min. West
141.2 feet to the BEGINNING, containing 2.35 acres.

The above metes and bounds description was taken from a plat
bearing No. 1078, entitled "Property Conveyance to Katherine E. Fisher,
Greenville County, South Carolina, Glassy Mountain Township," made by
H.B. Frankenfield, Jr., Forest Engr. and Surveyor, Tryon, N.C., dated
October 29, 1959; said property hereinabove conveyed being the pro-
perty shown on said plat, lying South of the North Carolina-South
Carolina State Line; reference being had to said plat in aid of the
description.
