to the grantor(s) in hand paid at and before the sealing of these presents by the grantee(s) (the receipts whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said **Giles A. Myers, his heirs and assigns:**

All that certain piece, parcel or lot of land situate, lying and being in the County of Greenville, State of South Carolina, being known and designated as Lot #8, on the northern side of Drexmoore Drive, property of Williams Land Co., Inc., according to plat by Jones & Sutherland, Engineers, dated December 1958, plat of which is recorded in the R.M.C. Office for Greenville County in Plat Book MM, at page 59, and according to a latter plat for Giles A. Myers, prepared by T. C. Adams and recorded in the R.M.C. Office for Greenville County in Plat Book UU at page 3, and according to said latter plat, having the following metes and bounds, to-wit:

BEGINNING at an iron pin on the Northern side of Drexmoore Drive at the joint front corner of lots #7 and #8, which iron pin is 91.5 feet West from the intersection of Drexmoore Drive and Longwood Drive; and running thence along the Northern side of Drexmoore Drive, S. 66-42 W. 100 feet to an iron pin at the joint front corner of lots #8 and #9; running thence with the joint line of said lots N. 18-15 W. 118.6 feet to an iron pin; running thence N. 52-02 E. 70 feet to an iron pin at the joint rear corner of lots #7 and #8; running thence with the joint line of said lots S. 32-45 E. 136.7 feet to an iron pin, point of beginning.
