

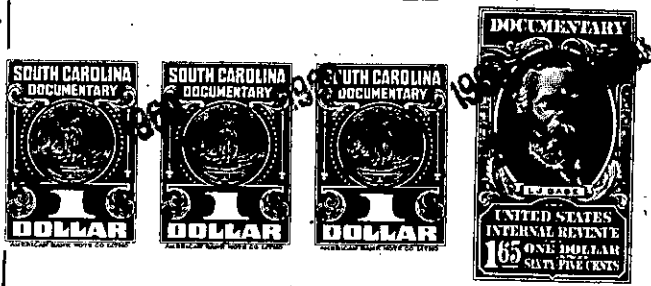

(the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said W. W. WILKINS, His Heirs and Assigns,

all that piece, parcel or lot of land in Greenville Township, Greenville County, State of South Carolina

ALL THAT certain piece, parcel or lot of land situate, lying and being in the City and County of Greenville, State of South Carolina, and being known and designated as lot No. 7 of Block "A" of the property known as Glenn Farms, according to a survey made by H. S. Brockman, Surveyor, August 26, 1943, and recorded in the R. M. C. Office for Greenville County in Plat Book M at page 75, and, according to said plat being more particularly described as follows:

BEGINNING at the North side of a County road at an iron pin joint corner of lots 7 and 8, and running along the line of lot No. 8, N. 60-45 W., 168.2 Feet to an iron pin joint rear corner of lots 7 and 8, thence N. 87-30 W., 24.4 feet to an iron pin; thence S. 29-15 W. 39 Feet to an iron pin at the joint rear corner of lots 6 and 7; thence along the line of lot No. 6, S. 60-45 E. 200 feet to an iron pin in the County road; thence along said County road N. 29-15 E. 50 feet to an iron pin, the beginning corner.

BEING a part of the same property conveyed to the Grantors by M. L. McDaniel, et al on March 2, 1953 as noted in Deed Volume 495, page 125, Office of the R. M. C. for Greenville County; AND Being one of the same two lots conveyed to the Grantors as noted in Deed Volume 584, at page 97, Office of the R. M. C. for Greenville County.
