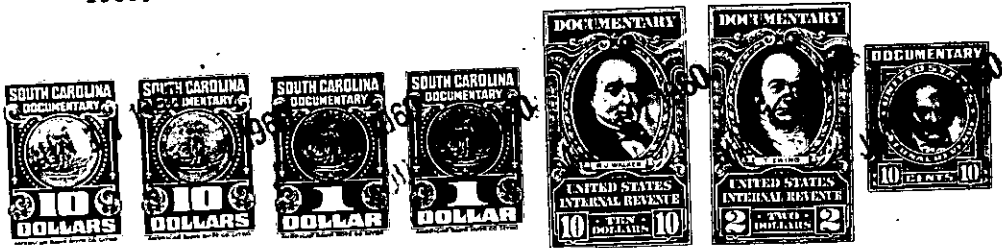
Know All Men by These Presents:

all that certain piece, parcel or lot of land situate, lying and being in the County and State aforesaid, town of Mafietta, on the N/S of Carswell Ave., being shown as Lot no Nine (9) on a plat of survey of the Duff property as shown by a survey made by Dean C. Deens, surveyor, April 2, 1956, plat of same being recorded in the R.M.C. Office of Greenville County in Vol. FF, page 404, and having according to said plat the following mates and bounds:
