BALTZ

All that parcel or lot of land lying and being in the County of Greenville, State of South Carolina, being designated as Lot No. 20 as shown on Plat No. Three, Cherokee Forest, prepared by J. Mac Richardson, R.L.S., in January, 1959, and recorded in the R.M.C. Office for Greenville County, South Carolina, in Plat Book QQ at pages 36 and 37, and having, according to said plat, the following metes and bounds:

BEGINNING at an iron pin on the northern side of Vicki Circle at the joint front corner of Lots Nos. 19 and 20 and running thence with the line of Lot No. 19 N. 4-31 E. 200 feet to an iron pin in the subdivision property line; thence with said subdivision property line S. 85-29 E. 100 feet to an iron pin at the joint rear corner of Lots Nos. 20 and 21; thence with the line of Lot No. 21 S. 4-31 W. 200 feet to an iron pin on the northern side of Vicki Circle; thence with the northern side of Vicki Circle N. 85-29 W. 100 feet to the point of beginning.
