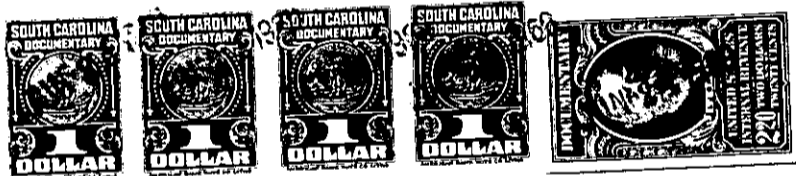
a corporation chartered under the laws of the State of South Carolina and having its principal place of business at Greenville in the State of South Carolina, for and in consideration of the

sum of One Thousand Eight Hundred Fifty and No./100ths (\$1,850.00)----- dollars, to it in hand duly paid at and before the sealing and delivery of these presents by the grantee(s) hereinafter named, (the receipt whereof is hereby acknowledged), has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto DONALD E. BALTZ

All that parcel or lot of land lying and being in the County of Greenville, State of South Carolina, being designated as Lot No. 19 as shown on Plat No. Three, Cherokee Forest; prepared by J. Mac Richardson, R.L.S., in January, 1959, and recorded in the R.M.C. Office for Greenville County, South Carolina, in Plat Book QQ at pages 36 and 37, and having, according to said plat, the following metes and bounds:

BEGINNING at an iron pin on the northern side of Vicki Circle at the joint front corner of Lots Nos. 18 and 19 and running thence with the line of Lot No. 18 N. 4-31 E. 200 feet to an iron pin in the subdivision property line; thence with said subdivision property line S. 85-29 E. 100 feet to an iron pin at the joint rear corner of Lots Nos. 19 and 20; thence with the line of Lot No. 20 S. 4-31 W. 200 feet to an iron pin on the northern side of Vicki Circle; thence with the northern side of Vicki Circle N. 85-29 W. 100 feet to the point of beginning.
