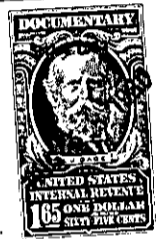
That I, J. Frank Williams, in the State aforesaid,

to the grantor(s) in hand paid at and before the sealing of these presents by the grantee(s) (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said Clyde L. Dorr, his heirs and assigns:

All that piece, parcel or lot of land situate, lying and being in Greenville County, South Carolina, and being shown as Lot No. 8 on a plat of Western Hills, plat of which is recorded in the R.M.C. Office for Greenville County in Plat Book QQ at Page 98-9, and, according to said plat, having the following metes and bounds, to-wit:

BEGINNING at an iron pin on the southerly side of Tucson Drive, at the corner of Lots Nos. 8 and 9, and running thence S. 35-23 E., 31.5 feet to an iron pin in the rear of Lot No. 7; thence with the line of said lot, S. 50-17 W., 194.4 feet to an iron pin on the easterly side of El Paso Drive; thence with the easterly side of El Paso Drive, N. 39-43 W., 48.7 feet to an iron pin; thence continuing with the curve of said Drive, the chord of which is N. 19-50 W., 93.9 feet to an iron pin; thence continuing with the curve of said drive, the chord of which is N. 45-15 E., 35.4 feet to an iron pin on the southerly side of Tucson Drive; thence with said drive, S. 89-45 E., 168.4 feet to the point of beginning.

The above described lot is conveyed subject to the recorded restrictions applicable to Western Hills and to the easements and right-of-way as shown on said plat.

TO HAVE AND TO HOLD all and singular the said Premises before mentioned unto the grantee(s) hereinabove named, and his Heirs and Assigns forever.

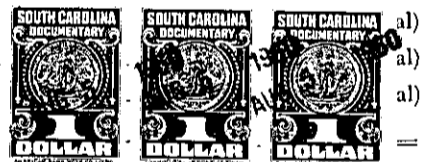
