to the grantor(s) in hand paid at and before the sealing of these presents by the grantee(s) (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said Larkin Chandler, his heirs and assigns forever:

All that lot of land in Greenville County, State of South Carolina, on Southern side of Shoals Drive, being near the community of Cleveland, South Carolina, shown as lot # 21 of Block 2, on a plat of Blocks 1, 2 and 3 of Silver Shoals, recorded in Plat Book MM at Page 35, and having according to said plat the following metes and bounds, to-wit:

BEGINNING at an iron pin on the southern side of Shoals Drive, at the front corner of lot # 1, Block 1, thence with the line of said lot, S. 8-44 E. 200 feet to iron pin on the northern side of Silver Circle; thence with the northern side of said Circle, S. 88-45 W. 80 feet to iron pin at the rear corner of lot # 22; thence with the line of said lot, N. 8-44 W. 200 feet to iron pin on the southern side of Shoals Drive; thence with the southern side of Shoals Drive, N. 88-45 E. 80 feet to the beginning corner.

This conveyance is made subject to restrictions recorded in Book of Deeds 548 at Page 324.

It is understood that the grantee shall have access and privileges of the use of the Middle Saluda River along with other property owners purchasing lots from the grantor with the exception of the river front area immediately in front of lot # 33 and west therefrom which is expressly reserved to the Grantor.

TO HAVE AND TO HOLD all and singular the said Premises before mentioned unto the grantee(s) hereinabove named, and his Heirs and Assigns forever.

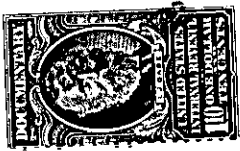

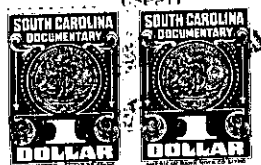
