All that piece, parcel or lot of land in Paris Mountain Township, County of Greenville, State of South Carolina, located on the Northern side of Perry Road Ext. (East Perry Road) and being shown as all of lot number TWENTY TWO (22) on a plat entitled "Leawood Hills", made for the within grantors by Terry T. Dill, surveyor, dated October 1958, and has the following metes and bounds according to said plat, to wit:

TOGETHER with all and Singular the Rights, Members, Hereditaments and Appurtenances to the said premises belonging, or in anywise incident or appertaining

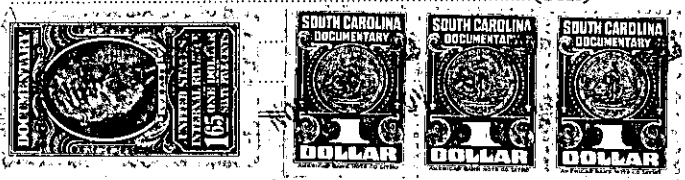
