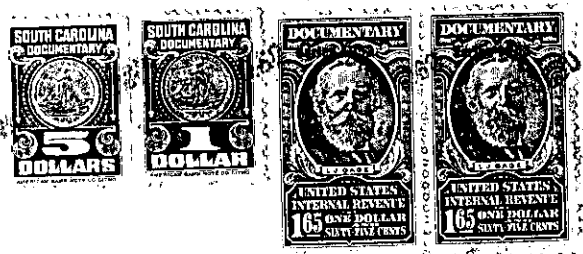
That I, Heyward Jackson

ALL that piece, parcel or lot of land situate, lying and being in the County of Greenville, State of S.C., near the corporate limits of the City of Greenville, and known and designated as Lot No. 10 of the property of Lillian M. Rushing as shown on plat thereof recorded in the RMC Office for Greenville County, S.C., in Plat Book V, page 37, and having according to said plat the following metes and bounds, to-wit;

BEGINNING at an iron pin on the southeastern side of Taylor Street (which iron pin is offset 4 feet from the line of said street) at a point approximately 92 feet south of the intersection of Brockman Street; thence S 71-06 E 86 feet to an iron pin; thence S 10-43 W 53 .8 feet to an iron pin; thence S 32-19 W 92 feet to an iron pin at the rear corner of Lot No. 9; thence along the line of Lot No. 9 N 61-24 W 100.7 feet to an iron pin (which iron pin is offset 5 feet from the line of said street) on the southeastern side of Taylor Street; thence along the southeastern side of Taylor Street N 28-36 E 46 feet to the beginning corner.
