BEATTIE B. BALENTINE, his heirs and assigns forever

ALL that piece, parcel or lot of land in Greenville Township, Greenville County, State of South Carolina on the Northwest side of Aberdeen Avenue, in the City of Greenville and being known and designated as LOT NO. 4 on Plat of Park Hill as shown by survey made by R. E. Dalton, July 1923 and recorded in the RMC Office for Greenville County in Plat Book F, at pages 135-136 and being described as follows:

BEGINNING at an iron pin on the Northwest side of Aberdeen Avenue at the joint front corner of Lots 4 and 5; said pin also being 99.8 feet in a Northwesterly direction from the point where the Northwest side of Aberdeen Avenue intersects with Elsie Street and running thence with the line of Lot 5, North 62-46 West 160 feet to an iron pin; thence along the rear line of Lot 10-D, North 27-10 East 80 feet to an iron pin; thence with the Line of Lot 3, South 62-43 East 155.7 feet to an iron pin on the Northwest side of Aberdeen Avenue; thence with the Northwest side of Aberdeen Avenue, South 22-54 West 60 feet to an iron pin; thence continuing with Aberdeen Avenue South 27-10 West 20 feet to the point of beginning.
