JACK G. ROBBINS, his heirs and assigns forever,

ALL that piece, parcel or lot of land in the County of Greenville, State of South Carolina, being known and designated as LOT NO. 12 on Mills Avenue and shown on plat showing a portion of Kirkwood Heights made by Pickell & Pickell, Engrs. dated June 28, 1960 and recorded in Plat Book RR, at page 45, RMC Office for Greenville County and having the following metes and bounds:
