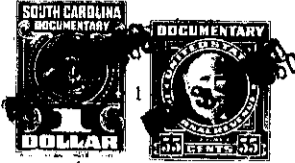

by acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release
unto the said GLEN K. HOCKENBURY, his heirs and assigns forever:

All that certain piece, parcel or lot of land in Grove Township, Greenville
County, State of South Carolina, one lot lying west of Highway 29, south
of Piedmont, S. C., adjoining property of Roy Allison, Grady Reeves,
J. H. Looper, and possibly others, having the following courses and
distances, to-wit:

BEGINNING at an iron pin corner of Grady Reeves and Roy Allison property;
thence along line of Roy Allison N. 45 W. 1 chain 21 links to iron pin;
thence along line of J. H. Looper S. 32 W. 3 chains 29 links to iron pin
center of surface treated road; thence along surface treated road N. 78 E.
1 chain 23 links to iron pin corner of Grady Reeves property; thence along
line of Grady Reeves N. 26 1/4 E. 2 chains 16 links to beginning corner,
